Planning for a new all-seasons mountain resort in southwest B.C., led by Spuzzum First Nation

Spuzzum First Nation is exploring the feasibility of creating the first Indigenous-led all-seasons mountain resort in B.C.

Located in previously-logged areas of Spuzzum's traditional territory, the South Anderson Mountain Resort (working title) would develop approximately 600 hectares of land for recreation and tourism. This includes 240 hectares of ski area and lift rights-of-way and 300-350 hectares of other development areas including day skier base lodge, recreation centre, utilities (wastewater treatment, potable water), a potential school, recreational vehicle park, hiking trails, etc.

The Project offers significant benefits for B.C. and Spuzzum First Nation

- Increased tourism and recreation opportunities for B.C. residents
- Economic self-reliance and sense of pride for Spuzzum
- Protection of the Central Anderson watershed for eco-tourism and Indigenous cultural purposes
- Construction employment and 800 operational jobs
- Sustainable regional economic development
- Application of environmental best practices
- Opportunity to profile First Nation entrepreneurship
- Significant opportunity for meaningful Reconciliation between Spuzzum and B.C.

Planning and engagement process

Spuzzum First Nation is planning the Project in accordance with our values, including engagement with Spuzzum community members, neighbouring First Nations, and non-Indigenous organizations. As part of our 5-year Economic Development Strategy, Spuzzum began planning for this Project in 2021. We will continue to engage throughout our ongoing feasibility and planning processes.

Seeking an Exemption Order under the B.C. Environmental Assessment Act

Spuzzum First Nation is seeking an exemption order from the EAO, which means that, if granted, the Project would not require an environmental assessment. Project oversight would then be carried out by various provincial ministries including the B.C. Mountain Resorts Branch and associated permitting and regulatory processes required for resort developments and operation.

Spuzzum is committed to fully considering the environmental and socio-community effects of the Project. We are seeking an exemption as we believe the Project meets EAO's requirements for an exemption. Specifically, we believe:

- The Project offers significant benefits for Indigenous Reconciliation and healthy First Nation communities in the region.
- Most of the proposed resort area has already been significantly disturbed by industrial logging, making the Project a lowimpact development.
- Spuzzum First Nation has extensive traditional knowledge of the area, which will be supplemented by existing and future studies as part of planning and permitting to inform how the resort interacts with remaining environmental features.
- Other federal and provincial regulatory processes are in place to effectively further explore, understand and manage how the proposed Project will interact with environmental values.
- The project benefits and environmental management measures available outweigh any potential negative impacts.
